### SECRETARY'S REPORT

#### Dear TMAins,

In the previous issue of Management Voice, I reported the new three-pronged approach that our dynamic president, Er. Vinod Manjila has envisaged in order to expand the TMA horizons over and above our regular activities - (1) Re-visioning TMA for the future, (2) Let's chat sessions, and (3) Giving back to the society. I will stick to the same reporting format in this issue also.

#### A. THE NEW THREE-PRONGED APPROACH

#### A1) Re-positioning TMA

In continuance of the re-positioning initiative, we standardized the design of TMA Management Voice cover, the brochures publicizing guest lectures, and the YouTube thumbnails on TMA YouTube channel. Moreover, we started publishing the TMA Management Voice, and quarterly reports in online flipbook format for easy perusal.

With the objective of bringing youngsters below the age of 40 into the TMA fold, we launched the Young Leaders of Thrissur (YLT) initiative in December under the convenorship of Mr. Seejo Ponnore. YLT will be a part of TMA with separate youth-oriented activities and programs of its own. YLT members will have the option of upgrading their membership to TMA life membership upon expiry of YLT membership, or any time before that.

#### A2) Let's Chat

Under the convenorship of the TMA vice president, CA. Geo Job, we had a second informal get together (Let's Chat) on the topic of tourism; the session was at Sakthan Palace, Thrissur on the 14th of November, 2021. Suggestions from the participants were collated, documented, and sent to the curator of the palace for further consideration.

In addition, the TMA team headed by the president met with the District Collector of Thrissur on the 7th of December, 2021 and mooted the idea of developing a master plan for Vilangan hills involving the architects of Thrissur. The purpose would be to vet all further developments at the site against the master plan. The collector was very receptive to the idea and promised to take it up her chain of command further for approval of the idea.

#### A3) Giving back to society

#### Industrial Mentoring

In conjunction with District Industries Centre (DIC), Thrissur, TMA conducted mentoring sessions with three different small scale industries in the food sector on the 3rd of November. A TMA expert team

under the convenorship of Dr. Assissi Menachery further studied the financial statements, cost structure, and operational aspects - Foster Foods Pvt. Ltd., Varadiam, Thrissur – and recommended an action plan to turn around the company and run it in a profitable mode.

Furthermore, TMA organized a training session for MSME business owners and executives on digital marketing by an expert in this field, Mr. Bhanu Kumar S (Founder Director, ARRA Associates). The training was conducted on the 25th of January in association with DIC and was supported my Madras Management Association (MMA.

#### Waste Management

TMA liaised with Green Worms (www.greenworms.org), a social impact-oriented sustainable waste management company, and three different panchayats in Thrissur district - Nattika, Thalikulam, and Valappad - to clear the backlog of non-organic waste from these panchayats for further processing. This helped win the trust of all stakeholders and people of these panchayats in the waste management capability. TMA further plans to effectively implement and institutionalize waste collection and processing in these panchayats with the help of Green Worms.

#### Vision 2040

Under the able leadership of its senior vice president, Mr. K Paul Thomas, TMA has undertaken the ambitious "Thrissur Vision 2040" initiative with the objective of creating a vision dossier. The initiative took shape on Kerala Day (1st November) in a meeting with Palakkad Management Association which has released a similar vision dossier for Palakkad. Informal meetings and conversations with key figures in Thrissur were held as a follow up.
